1. Candidate & Parents has to be present admission as per notified schedule along with all the original Documents and Total fees payable . If candidate is absent , He/ She forfeits his / her claim on the seat and the seat will be offered to the next candidate in the merit. If any such candidates report at the later stage, He/she will be considered only if seats are remaining vacant after completion of the respective admission Round.
2. Candidates has to arrange for full fees . Candidate will lose claim on allotted seat in case of non-payment of full fees for any reason.

5. Admission for Vacant Seat Round will continue till the seat remain vacant or as per State Common Entrance Test Cell Admission Cut Off date. Admission will be given as per inter-se-merit .
6. Forms submitted after 24th September 2025 (3:00 pm) shall be considered after the exhausting the candidate in Final Merit List.
